"2007년 APEC 사회안전망 능력배양 심포지움 참가"에 관한 출장보고서

표제 심포지움은 2007년 6.24(토)-25(일)간 호주에서 Jeff Harmer 장관(호주 가족복지부 Department of Families, Community Services and Indigenous Affairs) 주최로 개최되어 경제위기 및 자연재난 등에 대처하는 사회안전망의 역할, APEC SSNCBN(Social Safety Net Capacity Building Network, Special Task Force)의 향후 활동방향 등을 주제로 다룬바, 경과를 다음과 같이 보고함.

1. 심포지움 개요

가. 참석자

o 호주를 포함해 12개국(한국, 중국, 인도네시아, 말레이시아, 멕시코, 뉴질랜드, 필리핀, 싱가포르, 대만, 태국, 미국)에서 51명이 표제 심포 지움에 참석했음. 주최국인 호주 Department of Families, Community Services and Indigenous Affairs의 장관 및 차관이 참석

나. 구성

- o 본 심포지움은 개회세션, 재난관리(Disaster Management) 세션, 능력 배양(Capability Development) 세션, 단기 및 장기 복구(Short and Long-term Recovery) 세션, 경제위기 극복(Response to and Recovery from Economic Challenges) 세션, SSNCBN Members 회의 등으로 구성
- o 개회세션에서는 Jeff Harmer 호주 Department of Families, Community Services and Indigenous Affairs 장관의 개회사, 지역 원주민 대표의 인 사말, Peter Cosgrove 호주 퇴역 장군의 기조연설이 있었음.
 - Jeff Harmer 장관은 개회사에서 제4차 APEC SSNCBN 전문가 회의인 본 심포지움의 주제에 관해 설명하고 APEC역내에서 발

생하는 경제위기 및 자연재난에 대응하는 사회안전망의 역할에 대해 강조함. APEC역내 사회안전망 능력배양을 위해 2002년부터 활동해온 SSNCBN의 노고를 치하함.

- o 제1세션의 주제는 "Disaster Management"로 호주 가족복지부 차관 (Ms. Robyn McKay)의 주재하에 진행됨. 미국 의회 Homeland Security and Justice 부서 William Jenkins 국장이 "Community Preparedness and Response for Major Disasters"라는 주제로 미국 의 재난관리시스템에 대해 발표하였음.
- o 제2세션에서는 "Capability Development"에 대해 논의함(좌장: 한국 보건사회연구원 홍석표박사). 이 세션에서는 사회안전망의 지속적인 발전을 위해 능력배양의 중요성이 역설되었고, 특히 정부기관과 민 간조직간에 경제위기 및 자연재난에 대응하는 협조체제의 능력배양 이 강조됨. 호주 Department of Primary Industries and Fisheries의 북부지역 국장이 기조발표하였음.
- o 제3세션의 주제는 "Short and Long-Term Recovery"로 세계은행 Ms. Susan Wong 선임고문이 Financial assistance, Accommodation, Health, Education, Counselling, Supporting Vulnerable groups 등의 관해 발표하였음.
- o 제4세션에서는 경제위기에 대응하는 사회안전망 역할에 대해 호주 노동부 Ms. Linda Lipp이 기조발표하였음.
- o SSNCBN Members 회의에서는 한국보건사회연구원 홍석표 박사가 한국의 주도(한국보건사회연구원)로 2002년에 창설된 SSNCBN의 그동 안 활동사항에 대해 설명하였음. 그리고 향후 활동방향으로 Project 중 심으로 진행할 것이라고 천명함. 중국, 대만, 태국, 싱가포르는 APEC역내 사회안전망 능력배양에 힘써온 한국의 노고에 대해 치하하고 앞으로도 사회안전망 능력배양 활동에 한국이 주도적 인 역할을 해줄 것을 당부함.
