2 세부 내용

○ EQRC 2019(미국질적연구학회)는 질적연구방법을 적용한 교육학을 포함한 다양한 분야의 연구가 발표되고 논의되었음. 질적연구방법론과 질적연구를 사용한 논문에 대한 논의를 하였음. 관련 논문의 목록은 다음과 같음:

1. A Grounded-theory case study of continuing professional education in North Carolina law enforcement

- □ **Objective** : To explores the current and future landscape of continuing professional education(CPE) for Law Enforcement officers
- □ Methods : To apply situational analysis (Adele Clarke's) for secondary data paired with interviews of five persons ; To traces the history of CPE, the path of professionalization, the implementation , and the current and future state of CPE in North Carolina Law Enforcement
- □ **Results** : Indicates a system of CPE still faced with struggles of professionalization and an accepted space both within law enforcement and within the field of Adult Education
- □ **Implications** : Through mapping and understanding the system navigation, recommendations can be made for the future
- 2. New public management and the creation of a research marketplace : A case study analysis of police-academic partnerships
- □ **Objective** : To demonstrate how policing strategies are both effective and economically efficient
- □ **Methods** : For 15 months, we worked with two Canadian police services on a community crime prevention strategy which allowed to engage in ethnographic research as participant observers.

To analyze the qualitative field note date, digitally-recorded team meetings, and government reports and documents

- □ **Results** : The police emphasis on the quantitative outcome measures serves managerial concerns of organizational accountability rather than explore the strategy's impacts on clients and service providers
- □ **Implications** : The influence of broader reconfigurations of social and political discourse and policy have fueled the push to demonstrate impact in both policing and academe, facilitated the marketization of police-academic research, and resulted in shallow police-academic partnerships that are designed to game the system



3. Phenomenological study of teachers' use and perceptions of the impact of response to intervention on co-teaching in secondary level general education classrooms

- □ **Objective** : To explore teachers' use of and perceptions regarding the potential impacts, benefits, and barriers of Response to Intervention(RTI) on co-teaching in secondary level, general education classrooms
- □ **Methods** : To apply purposeful sampling selection and semi-instructional interview to develop deep understanding of teachers' understanding
- □ **Results** : General and special education teachers shared their insight and experience related to the benefits of incorporating RTI into co-taught classrooms.
- □ **Implications** : Simultaneously, teachers expressed different points of view related to barriers and overall impact of incorporating RTI into co-taught classrooms

4. The touch of grace module project: Exploring human services and nursing students perceptions on end-of-life and palliative care

- □ **Objective** : To explore student reflections on changing perceptions on end-of-life and palliative care
- Methods : Students viewed five modules such as content on definitions of palliative and hospice care, communication, pain and suffering, final days and grief and bereavement To apply a qualitative approach to analyze reflections for a deep analysis To employ constant comparison method of analysis
- □ **Results** : Four key themes were identified : using centering techniques before engaging with dying clients, recognizing non-verbal pain cues, acknowledging differing manifestations of death and dying among different cultures and engaging with knowledge on how to adequately respond to dying patients
- □ **Implications** : Findings point to emphasizing educating future professionals to develop a deeper awareness of the ecological environment of the patient and constantly reevaluate their human contention

5. A Mixed methods evaluation of an inclusive summer lunch program

- □ **Objective** : To evaluate an inclusive summer lunch program for the participating applying social development theory
- □ Methods : To apply a mixed method in which the research involved a series of qualitative interviews with parents whose children participated in the Summer Lunch Program during the summer of 2017 and 2018 together with quantitative measurement of social capital.



□ **Results and Implications** : The most tangible outcome of the program is the food and educational programming provided to students during the summer months. Secondary outcomes include the development of new social skills, preparation for new educational experiences, less screen time for children, and learning about the community and the people in it
